Prevention of Cruelty to Animals Amendment (Stock Animals) Bill 2015

Proposed amendments

- No. 1 **Definition of “intensive livestock keeping facilities”**
Page 3, proposed section 24W, lines 20 and 21. Omit all words on those lines. Insert instead:
intensive livestock keeping facility means any enclosed premises at which stock animals are regularly kept for more than 8 hours a day, being premises that:
(a) are used for commercial purposes, and
(b) are connected to an electrical source in accordance with the requirements of the Australian/New Zealand Wiring Rules.
- No. 2 **Definition of “monitoring”**
Page 3, proposed section 24W. Insert after line 21:
monitor, in relation to an alarm system, fire sprinkler system or equipment used to make a recording under section 24Z, includes regularly checking the system or equipment to ensure that it is operating properly.
- No. 3 **Monitoring of fire sprinkler systems**
Page 3, proposed section 24X (1), line 30. Insert “, monitored” after “installed”.
- No. 4 **Monitoring of alarm systems**
Page 4, proposed section 24Y (1), line 3. Insert “, monitored” after “installed”.
- No. 5 **Removal of requirement to record operations at livestock keeping facilities**
Page 4, proposed section 24Z, lines 18 and 19. Omit “**and intensive livestock keeping facilities**”.
- No. 6 **Removal of requirement to record operations at livestock keeping facilities**
Page 4, proposed section 24Z (1), line 20. Omit “or intensive livestock keeping facility”.
- No. 7 **Recording of abattoir operations**
Page 4, proposed section 24Z (1), line 21. Omit “all operations relating”. Insert instead “operations that are critical”.
- No. 8 **Recording of abattoir operations**
Page 4, proposed section 24Z (1), line 22. Omit “keeping, movement”. Insert instead “unloading”.

- No. 9 **Removal of requirement to record operations at livestock keeping facilities**
Page 4, proposed section 24Z (1), lines 22 and 23. Omit “or intensive livestock keeping facility”.
- No. 10 **Recording of abattoir operations**
Page 4, proposed section 24Z (2), line 24. Omit “the equipment”. Insert instead “at least one device”.
- No. 11 **Monitoring of equipment used to record abattoir operations**
Page 4, proposed section 24Z. Insert after line 26:
 (3) The proprietor of an abattoir must ensure that any equipment used for the purpose of making a video and audio recording under this section is regularly monitored.
- No. 12 **Removal of requirement to record operations at livestock keeping facilities**
Page 4, proposed section 24Z (3), line 27. Omit “or intensive livestock keeping facility”.
- No. 13 **Removal of requirement to record operations at livestock keeping facilities**
Page 4, proposed section 24Z (5), line 36. Omit “or intensive livestock keeping facility”.
- No. 14 **Removal of requirement to record operations at livestock keeping facilities**
Page 4, proposed section 24Z (8), line 46. Omit “or intensive livestock keeping facility”.
- No. 15 **Removal of requirement to record operations at livestock keeping facilities**
Page 5, proposed section 24ZA (1), lines 3 and 4. Omit “or intensive livestock keeping facility”.
- No. 16 **Inspection of recording of abattoir operations**
Page 5, proposed section 24ZA. Insert after line 11:
 (4) For the purposes of this section, *officer* includes a member of staff of the Food Authority who is appointed as an authorised officer or food safety auditor under the *Food Act 2003*.
